
SUBJECT : AUTHORITY TO CONDUCT WORKSHOP ON THE FY 2021 YEAR-END ASSESSMENT OF THE BUREAU OF AGRICULTURE AND FISHERIES STANDARDS - ORGANIC AGRICULTURE DIVISION (BAFS-OAD)

In order to fulfill its FY 2021 Year-End Assessment, the Bureau of Agriculture and Fisheries Standards – Organic Agriculture Division (BAFS-OAD) is hereby authorized to conduct a workshop on October 2021 in Region I.

On January 21, 2021, the Republic Act (RA) No. 11511 or An Act Amending the Organic Agriculture Act of 2010 took effect to recognize the Participatory Guarantee System as an alternative option for organic certification. Due to this development, the BAFS-OAD reorganized its structure and operations to complement the additional mandates stated in the RA 11511. With these changes, the BAFS-OAD deemed it necessary to assess its performance based on its physical, financial, and managerial accomplishments.




