**APPROVING THE FINAL DRAFT GUIDELINES FOR THE OPERATION OF PARTICIPATORY
GUARANTEE SYSTEM (PGS) GROUPS FOR ORGANIC CERTIFYING BODIES**

WHEREAS, Republic Act No. 10068 (RA No. 10068), otherwise known as the Organic Agriculture Act of 2010, was enacted to provide for the development and promotion of organic agriculture in the Philippines and for other purposes;

WHEREAS, Section 6 of RA No. 10068, created the National Organic Agriculture Board (NOAB) as the policy-making body of the National Organic Agriculture Program (NOAP), which is mandated to provide direction and general guidelines for the implementation of the NOAP;

WHEREAS, Republic Act No. 11511 (RA No. 11511), an Act amending the Organic Agriculture Act of 2010, reaffirms the policy of the State to promote, propagate, develop further and implement the practice of organic agriculture in the Philippines;

WHEREAS, RA No. 11511 amended RA No. 10068 by adding a new section (Section 14) on Participatory Guarantee System (PGS), which provides the basic principles, legal personality, certification, accreditation, organizational levels, promotion, training and inspection of, and incentives for PGS groups;

WHEREAS, Rule 14.3 of Section 14 (Participatory Guarantee System) of the IRR of RA No. 10068 as amended by RA No. 11511, mandates BAFS to *develop guidelines that will set out the principles, characteristics, composition, organization and procedures for the establishment and operation of PGS groups*; and

WHEREAS, following the principle of inclusivity and transparency among its stakeholders, the draft Department Circular developed by BAFS has been subjected to public consultation, and was revised accordingly.

NOW, THEREFORE, considering the foregoing, this Honorable Board, by virtue of the powers vested in it by RA No. 10068, as amended by RA No. 11511, has **RESOLVED, AS IT HEREBY RESOLVES**, to approve the Guidelines for the Operation of Participatory Guarantee System (PGS) Groups for Organic Certifying Bodies.

RESOLVED FURTHER, that the draft guidelines shall be subjected to further review of the Legal Service of the Department.

RESOLVED FINALLY, that once the draft guidelines have been found to be legally in order, the DA-BAFS shall endorse the draft guidelines to the Office of the Secretary for the approval and signature of the Department Secretary
