CONFIRMING THE RESULTS OF THE FINAL DELIBERATION OF NOMINEES BY THE NATIONAL TECHNICAL SEARCH COMMITTEE (NTSC) FOR THE NATIONAL ORGANIC AGRICULTURE ACHIEVERS AWARD (NOAAA) FY 2015

WHEREAS, Section No. 05 of Republic Act No. 10068 otherwise known as the "Organic Agriculture Act of 2010" established the National Organic Agriculture Program (Program);
