MANDATING ALL REGIONAL FIELD UNITS (RFUs) OF THE DEPARTMENT OF AGRICULTURE TO CONDUCT WRITESHOPS FOR PROJECT PROPOSALS IN THEIR RESPECTIVE JURISDICTIONS

WHEREAS, Section 5 of Republic Act No. 10068 otherwise known as the "Organic Agriculture Act of 2010" ("Act") established the National Organic Agricultural Program (NOAP);

WHEREAS, Section 5 of the Act also provides for the extension of assistance to local government units (LGUs), peoples' organizations (POs), non-government organizations (NGOs) and other stakeholders including individuals and groups who are practicing and promoting acceptable methods of organic agriculture as well as those who are willing to do other pertinent activities, and documentation and evaluation of the NOAP;

WHEREAS, to implement said provision of law, DA issued Administrative Order No. 01, Series of 2013 (GUIDELINES ON THE EVALUATION AND APPROVAL OF ORGANIC AGRICULTURE PROJECT PROPOSALS);

WHEREAS, in its 19th Meeting on 18-19 June 2013 deemed it imperative to mandate the Regional Field Units of the Department of Agriculture conduct write shops in their respective jurisdictions in order to promote the submission of project proposals by all interested entities allowed under DA AO 01, s-2013;

NOW, THEREFORE, this Honorable Board, by virtue of the powers vested in it by RA 10068, has RESOLVED, as it hereby RESOLVES, to mandate all DA Regional Field Units conduct write shops for project proposal in their respective jurisdictions;

RESOLVED, FURTHER, that the Secretaries of Agriculture and Regional Executive Directors of RFUs be furnished copies of this Resolution, for reference.




