RECOMMENDING THE ASSIGNMENT OF ONE (1) VEHICLE OF THE BUREAU OF AGRICULTURE AND FISHERIES STANDARDS (BAFS) TO THE NATIONAL ORGANIC AGRICULTURE PROGRAM NATIONAL PROGRAM COORDINATING OFFICE (NOAP - NPCO)

WHEREAS, Section No. 05 of Republic Act No. 10068 otherwise known as the "Organic Agriculture Act of 2010" established the National Organic Agriculture Program (Program);

WHEREAS, the Honorable Board is the policy-making body mandated under Section 6 of RA No. 10068 to provide direction and general guidelines for the implementation of the Program;

WHEREAS, as the policy-making body providing direction and guidance for the implementation of the program the NOAB deems it proper to provide institutional support for the effective implementation of the National Organic Agriculture Program (NOAP);

WHEREAS, the Office of the Secretary of the Department of Agriculture by virtue of Special Order No. 18 dated 04 January 2016, designated the Bureau of Soils and Water Management (BSWM) as the National Program Coordinating Office of the National Organic Agriculture Program;

WHEREAS, there is a need to support the NOAP NPCO with the necessary resources to perform its mandate;

WHEREAS, there is a vehicle, Isuzu Crosswind (SHR 989), purchased with the use of organic funds;

WHEREAS, the said vehicle is in the custody of the Bureau of Agriculture and Fisheries Standards by virtue of Memorandum dated 25 January 2016, duly approved by the Honorable Secretary of the Department of Agriculture and Chairman of this Honorable Board;

WHEREAS, considering the limited resources of the NOAP NPCO, the NOAB deems it proper that the said vehicle be assigned for the use of the NOAP NPCO in the execution of their functions;

NOW, THEREFORE, considering the foregoing, the NOAB resolves as it is hereby resolved to recommend the transfer of the Isuzu Crosswind (SHR 989), for the use of

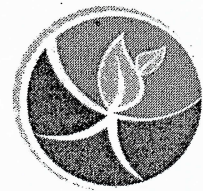
