APPROVING AND ADOPTING THE CONDUCT OF MONITORING OF NATIONAL ORGANIC AGRICULTURE PROGRAM (NOAP) FUNDED PROJECTS APPROVED BY THE NATIONAL ORGANIC AGRICULTURE BOARD (NOAB)

WHEREAS, Section No. 05 of Republic Act No. 10068 otherwise known as the "Organic Agriculture Act of 2010" established the National Organic Agriculture Program (Program);

WHEREAS, the Honorable Board is the policy-making body mandated under Section 6 of RA No. 10068 to provide direction and general guidelines for the implementation of the Program;

WHEREAS, Section 9 of the Implementing Rules and Regulations of the RA 10068 provides that the National Organic Agriculture Board (NOAB) shall monitor and evaluate the performance of the program;

WHEREAS, NOAB Resolution No. 012 S. 2013 entitled: "Approving and Adopting the Increase of Approval Ceiling of the IAs and RFUs from FIVE MILLION PESOS (Php5M) to TEN MILLION PESOS (Php10M), amended the Administrative Order No. 01, Series of 2013, *Rules and Procedures on the Evaluation, Approval and Implementation of Organic Agriculture Project Proposal*, thereby authorizes the NOAB to approve project proposals amounting to Php10,000,001 and above

WHEREAS, the NOAB instructed the National Organic Agriculture Program - National Program Coordinating Office (NOAP-NPCO) to spearhead the conduct of activities relative to the monitoring of the NOAP funded projects approved by the NOAB with the objective of evaluating its progress, impact and sustainability;

WHEREAS, the NOAP-NPCO with the guidance of the NOAB crafted a Project Monitoring and Evaluation Report Form as a tool for the monitoring of the NOAP funded projects;

NOW, THEREFORE, this Honorable Board, by virtue of the powers vested in it by RA 10068, has **RESOLVED**, as it hereby **RESOLVES**, to approve and adopt the conduct of monitoring of NOAP funded projects amounting to Php10,000,001 and above

RESOLVED, FURTHER, that a monitoring task force composed of the NOAB members, the NOAP NPCO, NOAB Secretariat and the respective regional OA Focal Person shall be created; and the approved Project Monitoring and Evaluation Report Tool (Annex A) shall be used for this purpose;

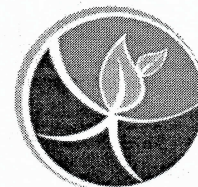
