SUBJECT : ADDENDUM TO SPECIAL ORDER NO. 842, SERIES OF 2021 RE: AUTHORITY TO CONDUCT SERIES OF TRAINING ON INSPECTIONS OF FARMS UNDER PARTICIPATORY GUARANTEE SYSTEM (PGS) AND AUDITS OF ORGANIC CERTIFYING BODIES (OCBs) FOR THE BUREAU OF AGRICULTURE AND FISHERIES STANDARDS - ORGANIC AGRICULTURE DIVISION (BAFS-OAD) PERSONNEL FOR FY 2021 TO 2022
