Resolution No. 017 Series of 2021

APPROVING THE ADOPTION OF A DIGITAL PLATFORM TO ADDRESS THE INFORMATION & OPERATIONAL-SUPPORT REQUIREMENTS OF THE NATIONAL ORGANIC AGRICULTURE PROGRAM

WHEREAS, Section 5 of Republic Act No. 10068 (RA 10068), otherwise known as "The Organic Agriculture Act of 2010' established the National Organic Agriculture Program (NOAP);

WHEREAS, the National Organic Agriculture Board (NOAB) is the policy-making body mandated under Section 6 of RA 10068, to provide direction and general guidelines for the implementation of the Program;

WHEREAS, RA 10068 has been amended by RA 11511, which took effect on January 21, 2021, and Section 2 thereof states to the effect, that a nationwide educational and promotional campaign shall be undertaken on the benefits of organic agri-products, as well as the adoption of organic agricultural system as a viable alternative, which is essential in achieving the overall objective of RA 10068, as amended, to promote, propagate, develop further, and implement the practice of organic agriculture in the Philippines;

WHEREAS, Section 20 of the Implementing Rules and Regulations of RA 10068 tasks the Agribusiness and Marketing Assistance Service of the Department of Agriculture, in collaboration with other relevant agencies, to develop and implement market development and trade promotion programs for organic agriculture;

WHEREAS, Department of Agriculture Secretary William D. Dar established the Farm and Fisheries Clustering and Consolidation Program, also known as the F2C2 Program, that encourages the formation of farming or fishing clusters for communal production, processing, marketing including the pooling of assets and capabilities;

WHEREAS, the NOAB deems it fit to adopt the F2C2 Program for a coordinated approach on the provision of interventions of the NOAP, consequently establishing Organik Konek, the NOAP's response and embodiment for the need for business integration in organic agriculture;

WHEREAS, among the key strategies of the Department of Agriculture is the digitalization of agriculture technology that will leverage the food value chain and logistics, through the adoption of automated systems that will improve farm productivity and cut waste, use of analytics to facilitate data-driven farming practices for small farmers, seamless linkages of electronic marketplaces with marketing service applications for interoperability and fast delivery to consumers, and modern crop monitoring by means of electronic databases, with the overarching aim to introduce and strengthen the digitization of farming and agribusiness activities in the country in order to make way for "Agriculture 4.0";

WHEREAS, VERDANT has agreed to grant the NOAB, the right to use the PLATFORM as its modest contribution to help the NOAB achieve its objectives and digitalization agenda;

NOW, THEREFORE, considering the foregoing, this Honorable Board, by virtue of the powers vested in it by RA 10068, as amended by RA 11511, has **RESOLVED**, as it hereby **RESOLVES**, to approve the adoption and use of Agro-DigitalPH as the digital platform to address the information and operational-support requirements of the NOAP;

RESOLVED, FURTHER, that the NOAB through the NOAP-NPCO shall promote and endorse the use of the digital platform in the organic ecosystem of stakeholders that includes, but are not limited to, producers, consumers, marketers, consolidators, and relevant government agencies;

RESOLVED, FURTHER, that the NOAP-NPCO, together with VERDANT, shall jointly develop an agreement for the use and management of the digital platform, incorporating therein a transition and onboarding program to ensure adoption of the digital platform that includes orientation sessions on the rationale, objectives, and use of the digital platform with DA-RFO OA Focals, provincial, city, and municipal agriculturists, and organic agri-farmers groups, cooperatives, and associations, in accordance with the resolution of this Honorable Board;

RESOLVED FURTHER, that it authorizes Secretary William D. Dar to enter into a Memorandum of Understanding with the Verdant Seasons Farm Management Technologies Corporation, the owner and operator of digital provider Agro-DigitalPH on the adoption of Digital Platform to address the information & operational-support requirements of the National Organic Agriculture Program
