NATIONAL ORGANIC AGRICULTURE BOARD RESOLUTION NO. 26 SERIES OF 2012

RESOLUTION INCREASING THE AUTHORITY OF IMPLEMENTING AGENCIES' AND REGIONAL FIELD UNITS' TO APPROVE PROJECT PROPOSALS AMOUNTING TO FIVE MILLION PESOS (P5,000,000,00) FOR THE FISCAL YEAR OF 2012

WHEREAS, on the third quarter of the first year of implementation of the National Organic Agriculture Program it was found out that there is a very low utilization level of the program funds;

WHEREAS, the low level of fund utilization can be attributed to the limited authority of Implementing Agencies and Regional Field Units to approve project proposals in their respective jurisdictions;

WHEREAS, there is an immediate need to meet this challenge in order to facilitate the success of the program and to cope with the administrative requirements of Government budget, accounting and auditing rules.

NOW, THEREFORE, it is hereby RESOLVED, to increase the authority of Implementing Agencies' and Regional Field Units' to approve project proposals amounting to FIVE MILLION PESOS (P5,000,000,00) from ONE MILLION FIVE HUNDRED THOUSAND (P1,500,000.00) for the Fiscal Year 2012;

RESOLVED FURTHER, to require the Regional Field Units and Implementing Agencies to submit their work and financial plan, catch up plans and implementation reports;

RESOLVED FINALLY, to furnish the office of the Agriculture Secretary a copy of this resolution.
