## NOAB Resolution No. <u>047</u> Series of 2013

## APPROVING AND ADOPTING THE GUIDELINES FOR PROVISION OF PRODUCTION SUPPORT SERVICES FOR ORGANIC AGRICULTURE

**WHEREAS,** Section 5 of Republic Act No. 10068 otherwise known as the "Organic Agriculture Act of 2010" established the National Organic Agricultural Program ("NOAP" or "Program");

**WHEREAS,** this Honorable Board, being the policy-making body of the Program, approved the 2012-2016 NOAP;

**WHEREAS**, the Program provides that proper production and technology support is vital in sustaining the interest of farmers and their eagerness to upscale and/or shift to organic farming;

**WHEREAS**, during the 21<sup>st</sup> NOAB Meeting on 13-14 August 2013, this Honorable Board agreed to approve and adopt a uniform Guidelines for Provision of Production Support Services for Organic Agriculture;

**NOW, THEREFORE,** this Honorable Board, by virtue of the powers vested in it by RA 10068, has RESOLVED, as it hereby RESOLVES, to approve and adopt the attached (Annex A) Guidelines for Provision of Production Support Services for Organic Agriculture;

**RESOLVED, FURTHER**, that the Secretary of Agriculture and heads of implementing units be furnished with copies of this Resolution, for reference and appropriate action.
