

NATIONAL ORGANIC AGRICULTURE BOARD Resolution No. 15 Series of 2016

RECOMMENDING THE PARTICIPATION OF THE DEPARTMENT OF AGRICULTURE (DA) IN THE TERRA MADRE SALONE DEL GUSTO 2016 TO BE FUNDED UNDER THE ORGANIC AGRICULTURE FUNDS

WHEREAS, Section No. 05 of Republic Act No. 10068 otherwise known as the "Organic Agriculture Act of 2010" established the National Organic Agriculture Program (Program);

WHEREAS, the Honorable Board is the policy-making body mandated under Section 6 of RA No. 10068 to provide direction and general guidelines for the implementation of the Program;

WHEREAS, Rule 5.7 Section 5 of the RA 10068 states that the DA must develop and institutionalize the promotion of local and international trade fairs, market promotion and matching activities with the active participation of LGUs, NGOs, NSAs, Academe, RDE institutions, organic farmer associations, business groups and multi-stakeholder (environment and climate change advocates and agrarian reform communities) networks to push organic products in the local and international markets as outlined in the comprehensive NOAP;

WHEREAS, the Program aims for the promotion of organic agriculture in order to raise public's awareness and consciousness on its benefits, and encourage responsible consumerism that protects both the consumers and the producers as well as the environment;

WHEREAS, the participation of the DA in Terra Madre Salone del Gusto 2016 shall be an avenue to showcase and promote 46 organic and heirloom products, listed in Annex A, that are included in the Ark of Taste, an international registry of gastronomic diversity, created to protect the existence of such products and advocate their preservation thru buying, consuming and supporting its producers;

WHEREAS, this year shall be the third participation of the DA in the said trade show where the Philippine booth shall showcase local products and dishes, and highlight traditional methods and sustainable practices of our local farmer producers and practitioners;

WHEREAS, the participation to the said trade show will entail cost for space rental and booth construction amounting to PhP 2,350,000.00;
