APPROVING THE FY 2025 THRUSTS AND PRIORITIES OF THE NATIONAL ORGANIC AGRICULTURE PROGRAM FOR PLANNING AND BUDGETING PURPOSES

WHEREAS, Section 2 of Republic Act No. 10068 or the Organic Agriculture Act of 2010, as amended by Republic Act No. 11511, declares the policy of the State to promote, propagate, develop further, and implement the practice of organic agriculture in the Philippines;

WHEREAS, Section 5 of R.A. 10068, as amended, established the National Organic Agriculture Program (NOAP);

WHEREAS, Section 6 of R.A. 10068, as amended, created the National Organic Agriculture Board (NOAB) as the policy-making body that shall provide direction and general guidelines for the implementation of the NOAP;

WHEREAS, presented to the Board during its 29 November 2023 meeting is the initial set of thrusts and priorities of the NOAP for Fiscal Year 2025 (FY 2025);

WHEREAS, this set of thrusts and priorities enumerates the strategic interventions and activities to address specific key result areas that will further promote, develop and improve the practice of organic agriculture in the country and advocate organic certification through the Participatory Guarantee System (PGS);

WHEREAS, this set of thrusts and priorities took into consideration all ongoing NOAP subprograms, projects and activities that are proposed to be continued and expanded, emerging needs and requirements of the organic agriculture sector, feedback from stakeholders and NOAP operating units, and the directives from the Department of Agriculture (DA) management and legislative bodies;

WHEREAS, this set of thrusts and priorities clarifies what programs, projects and activities will be funded by the NOAP funds, and provides the general direction and guidance of the NOAP operating units in preparing their respective FY 2025 plan and budget proposals;



NATIONAL ORGANIC AGRICULTURE PROGRAM (NOAP) FY 2025 THRUSTS AND PRIORITIES

The following are the strategic thrusts and priorities of the NOAP to serve as guidance in preparing its FY 2025 Plan and Budget Proposal (PBP) based on key result areas:

- 1. Expansion of certified organic agriculture (OA) areas through accreditation of core Participatory Guarantee System (PGS) group and organic certification of PGS group farmer-members to increase the number of certified organic farms and the volume of certified organic produce
 - 1.1. Conduct of capability building activities for farmers' groups and implementers towards accreditation of core PGS Groups as Organic Certifying Bodies (OCBs) and organic certification of PGS group farmer-members
 - 1.2. Provision of incentives to PGS-OCBs for farmer-members certified
 - 1.3. Conduct of PGS accreditation and certification activities such as consultations, field/farm validation, coaching and mentoring from pre-assessment to post accreditation
 - 1.4. Provision of assistance such as capability building, shed, small scale irrigation system, buffer plants, facilities, tools and equipment to resolve non-compliances (NCs) of farms for PGS organic certification
- 2. Consistency of supply of certified organic inputs to target beneficiaries

 - 2.3. Provision of support to DA Stations that are organic certified and/or ongoing organic certification process
- 3. Enhancement of organized Organic Agriculture Practitioners
 - 3.1. Provision of OA Livelihood Projects (OALP)
 - 3.2. Provision of small-scale irrigation systems
- 4. Self-sufficiency in the supply of organic soil amendments, biocontrol agents and farm inputs
 - 4.1. Establishment of fertilizer production facilities such as Small Scale Composting Facilities (SSCF) and Composting Facilities for Biodegradable Wastes (CFBW)
 - 4.2. Provision of Molasses and African Night Crawlers (ANC)
 - 4.3. Establishment of facilities for biocontrol agents
 - 4.4. Establishment of botanical concoction facilities and support machinery and equipment
 - 4.5. Conduct of capacity building activities for farmer and LGUs to produce their own soil amendments


