ADOPTING THE 16TH NATIONAL ORGANIC AGRICULTURE CONGRESS (NOAC) PLENARY RESOLUTIONS

WHEREAS, Section No. 05 of Republic Act No. 10068 otherwise known as the "Organic Agriculture Act of 2010" established the National Organic Agriculture Program (NOAR);

WHEREAS, the Honorable Board is the policy-making body mandated under Section 6 of RA No. 10068 to provide direction and general guidelines for the implementation of the Program;

WHEREAS, the conduct of the National Organic Agriculture Congress is one of the activities that will help improve and carry on the Program;

WHEREAS, during the 16th NOAC held on November 12-14, 2019 at Camp Benjamin, Alfonso, Cavite, organic stakeholders came up with forty-one (41) resolutions to further develop and promote the Program.

NOW, THEREFORE, considering the foregoing, this Honorable Board, by virtue of the powers vested in it by RA 10068, has RESOLVED, as it hereby RESOLVES, to adopt the 16th NOAC Plenary Resolution (ANNEX) for further discussion.


