NATIONAL ORGANIC AGRICULTURE BOARD Resolution No. <u>19</u> Series of 2020

RECOMMENDING THE APPROVAL OF THE REVENUE REGULATION ON THE IMPLEMENTATION OF THE INTERNAL REVENUE TAX INCENTIVES PROVISIONS © REPUBLIC ACT NO. 10068 OR THE ORGANIC AGRICULTURE ACT OF 2010

WHEREAS, Section No. 05 of Republic Act (RA) No. 10068 otherwise known as the "Organic Agriculture Act of 2010" established the National Organic Agriculture Program (NOAP);

WHEREAS, the Honorable Board is the policy-making body mandated under Section 6 of RA No. 10068 to provide direction and general guidelines for the implementation of the Program;

WHEREAS, pursuant to the provisions of Section 244 and 245 of the National Internal Revenue Code (NIRC) of 1997, as amended, in relation to Section 24 of R.A. No. 10068 otherwise known as the "Organic Agriculture Act of 2010" these regulations are hereby promulgated to implement the tax provisions of the Act;

WHEREAS, Section 86 (II) of R.A. 10963 otherwise known as the Tax Reform for Acceleration and Inclusion (TRAIN) Law states that Section 24 (e) of RA No. 10068 pertaining to the provision of Zero-Rated Value Added Tax has been repealed;

WHEREAS, income tax holiday and exemption for seven (7) years, starting from the date of registration of organic food and organic input producers on all income taxes levied by the National Government;

WHEREAS, a revenue regulation shall be approved to supplement the Implementing Rules and Regulations promulgated by the Department of Agriculture (DA) in consultation with the Bureau of Internal Revenue (BIR) and the Department of Finance (DOF);

NOW, THEREFORE, considering the foregoing, this Honorable Board, by virtue of the powers vested in it by RA 10068, has RESOLVED, as it hereby RESOLVES, to recommend the approval of the revenue regulation for the implementation of internal revenue tax incentives provisions of RA No. 10068.

RESOLVED, FINALLY, that the DA and the BIR shall recommend the approval of the Revenue Regulation to the DOF.
