## CONDUCT OF STUDY ON THE PROPOSED BASIC PAYMENT SCHEME: AN INCENTIVE SCHEME FOR ORGANIC AGRICULTURE

**WHEREAS**, Section 2 of Republic Act No. 10068 or the Organic Agriculture Act of 2010, as amended by Republic Act No. 11511, declares the policy of the State to promote, propagate, develop further, and implement the practice of organic agriculture in the Philippines;

**WHEREAS**, Section 6 of R.A. 10068, as amended, created the National Organic Agriculture Board (NOAB) as the policy-making body that shall provide direction and general guidelines for the implementation of the National Organic Agriculture Program (NOAP);

**WHEREAS,** Section 25 of R.A. 10068, as amended, states that the government shall provide incentives to farmers whose farms have been duly certified as compliant with the Philippine National Standards (PNS);

**WHEREAS**, the Philippines is a recipient of an Asian Development Bank Technical Assistance Project (ADB TA-10009 PHI) entitled "Accelerating Climate Resilience in Agriculture, Natural Resources and the Environment" where one of the project outputs is the expansion of organic agriculture in the country;

WHEREAS, the National Organic Agriculture Program (NOAP) has requested the ADB consultants involved in the project to look into an incentive scheme for organic agriculture similar to the Basic Payment Scheme (BPS) being implemented in the United Kingdom; Under the BPS, farmers are paid for carrying out eligible agricultural activities; the scheme also delivers environmental and other benefits by requiring farmers to meet certain practices and farm in a sustainable way;

**WHEREAS,** Dr. Saturnina C. Halos, one of the ADB Consultants, presented to the NOAB Technical Working Group the proposed basic payment scheme where farmers are paid regularly in cash to continue using practices for sustainable agriculture; Dr. Halos informed that paying organic farmers cash incentives by adopting organic farm practices is a poverty reducing strategy; and that cash payments maybe used by farmers to scale up and find better markets for their produce;

WHEREAS, the proposed basic payment scheme shall institute a cash payment scheme for small farmers for the adoption of sustainable farming practices such as organic farming; that cash incentives are provided to ensure that practices of climate resilience and sustainable agriculture are continuously adopted; and that these incentives shall comprise of regular periodic cash payments per practice commensurate to the value of the benefit expected and/or derived from the practice by the public and future generations;

**WHEREAS,** the proposed Basic Payment Scheme (BPS) was presented to the NOAB Technical Working Group during its meeting last 7 May 2024, and it was agreed that further study should be conducted to design a BPS that is appropriate for smallholders to understand and engage with limited risks to them; that the scheme allow opportunities for farmers to choose individual actions specific to their needs reaching across food production and improvements in farm productivity and climate resilience, while also protecting and improving the environment; the scheme should be flexible with a range of options from which the farmers can prioritize where and how the scheme is relevant to them;
